Target Market	<ul style="list-style-type: none"> • Individual primary producers holding a Savings or Transactional Product who are eligible to shift before-tax income by investing a fixed amount of funds for a fixed term at a fixed interest rate. • Located in or associated with North East Victoria and Southern New South Wales <p>Description of product, including key attributes</p> <p>Farm Management Deposits, key features of this product are:</p> <ul style="list-style-type: none"> • Available to individual primary producers holding a savings or transactional product. • The minimum deposit is \$1,000 and the maximum deposit is \$800,000 at any one time in any year of income. • The minimum term is 12 months. • There are no account keeping fees. • Interest rates vary according the term of the deposit, the amount of the deposit, and frequency of payment of interest. • Interest is calculated on the daily balance and reflects the number of days in the interest payment period. • Interest will be paid on maturity to a nominated savings or transactional product. • Principal repayments may be made directly to a BankWAW account, by BankWAW corporate cheque, or by Electronic Funds Transfer. • Money cannot be added to the principal during the unexpired term of the deposit. • If written instructions are not received prior to maturity, the Farm Management deposit will be re-invested for the same term (or up to a maximum of 24 months) at the current standard rate. • BankWAW may consider a written request from the customer for the full or partial redemption of the deposit before maturity, but shall have the right to adjust the interest rate payable on the deposit to the base rate for the S51 Everyday Saver applicable at the date of the written request. <ul style="list-style-type: none"> ○ In the case of a partial redemption the interest will accrue for payment upon maturity; ○ Where the term deposit has already paid interest, full or partial redemption of the deposit before maturity may require repayment of interest already paid. • The deposit cannot be used as security for any amount owed to BankWAW or any person by the depositor or any other person. • This account does not have access to the following facilities: <ul style="list-style-type: none"> ○ Over-the-counter withdrawals during the unexpired term of the deposit (excluding account closure withdrawal). ○ Internal and external online transfer during the unexpired term of the deposit. ○ BPAY facilities, including BPAY View.
